PLEASE READ IMPORTANT NOTES ON BACK

Note 1	At this AGM there are 6 positions for election, ONE Senior Male Cultural Advisor and Director, ONE Senior Female Cultural Advisor and Director, ONE male director under 35 years of age, ONE female director under 35 years of age, ONE female director and ONE male director. Directors are elected for a period of 2 years (until the 2021 AGM).
Note 2	The proposer, seconder and nominee must all be members of AMYAC. A person is a member if their name is listed on the Register of Members.
Note 3	Those members who do not have a True Blood Line or a Long Time/Term Physical and Spiritual Association with the Antakirinja Matu-Yankunytjatjara Native Title area do not have a right to vote at this meeting <u>or be elected or appointed as a director of AMYAC.</u> See: Rule 6.8.3
Note 4	That you cannot nominate to be elected a director of AMYAC if you are a director of another Registered Native Title Body Corporate, Prescribed Body Corporate or native title claim group. See: Rule 9.2.1 (a)

IMPORTANT:

ONLY ONE IMMEDIATE FAMILY MEMBER CAN BE A DIRECTOR AT ANY ONE TIME

See: Rule 9.2.2 (i)

This means that if you already have an "Immediate Family Member" on the board who has another year left as a director you cannot nominate until their term expires.

It also means that 2 or more "Immediate Family Members" cannot nominate for election at the same time. If this happens those persons will be advised and given the opportunity to choose which one will be the nominee for your family. If no choice is made <u>none</u> of those nominees will be eligible to stand and none of them will appear on the ballot paper.

See: Rule 9.5.2 (b) & (c)

An "Immediate Family Member" means a husband and wife, biological parent and child, biological grandparent and grandchild, biological brothers and sisters.
