Purpose of the commissioned artwork?

Purpose of artwork: To visually represent and acknowledge the relationship between AMYAC and Peak Iron Mines, which will continue to grow during the life of the Buzzard Project.

What are we looking for?

Peak Iron Mines is currently constructing the Buzzard Project, which is located within the Hawks Nest Exploration Lease (EL), halfway between Coober Pedy and Glendambo in the Gawler Craton.

We would like to visually represent and acknowledge the relationship between AMYAC and Peak Iron Mines by commissioning a piece of artwork by an Antakirinja Matu-Yankunytjatjara artist, to be displayed in our Adelaide office.

We want the symbolism of the artwork to align with AMYAC principles, which AMYAC and Peak Iron Mines have agreed to embrace as they strive to work together. The principles are:

- i *tjunguringanyi* (coming together);
- ii *pulkuringanyi* (learning);
- iii *tjukurat* (strong);
- iv *iwaru* (walking together); and
- v *ngarpartji ngarpartji* (reciprocity).

Who can apply?

Applicants must identify as Antakirinja Matu-Yankunytjatjara.

How to apply?

Please provide photos or papers of the following:

- A description of your proposed artwork and how it visually represents and acknowledges the relationship between AMYAC and Peak Iron Mines and the new Buzzard project.
- A detailed colour sketch of your proposed artwork.
- If possible, examples of your other completed artwork.

How will the applicant be selected?

A review of application submissions will be undertaken by a selection panel to be as independent as possible but also include AMY representatives to fact check the application.

The selection panel to be comprised of:

- Peak Iron Mines Project Director – Rob Morrow.
- AMYAC CEO – Michael Coughlan.
- Two AMYAC directors – one (1) male and one (1) female director.
- Peak Iron Adelaide Office Manager – Diona Antonas.

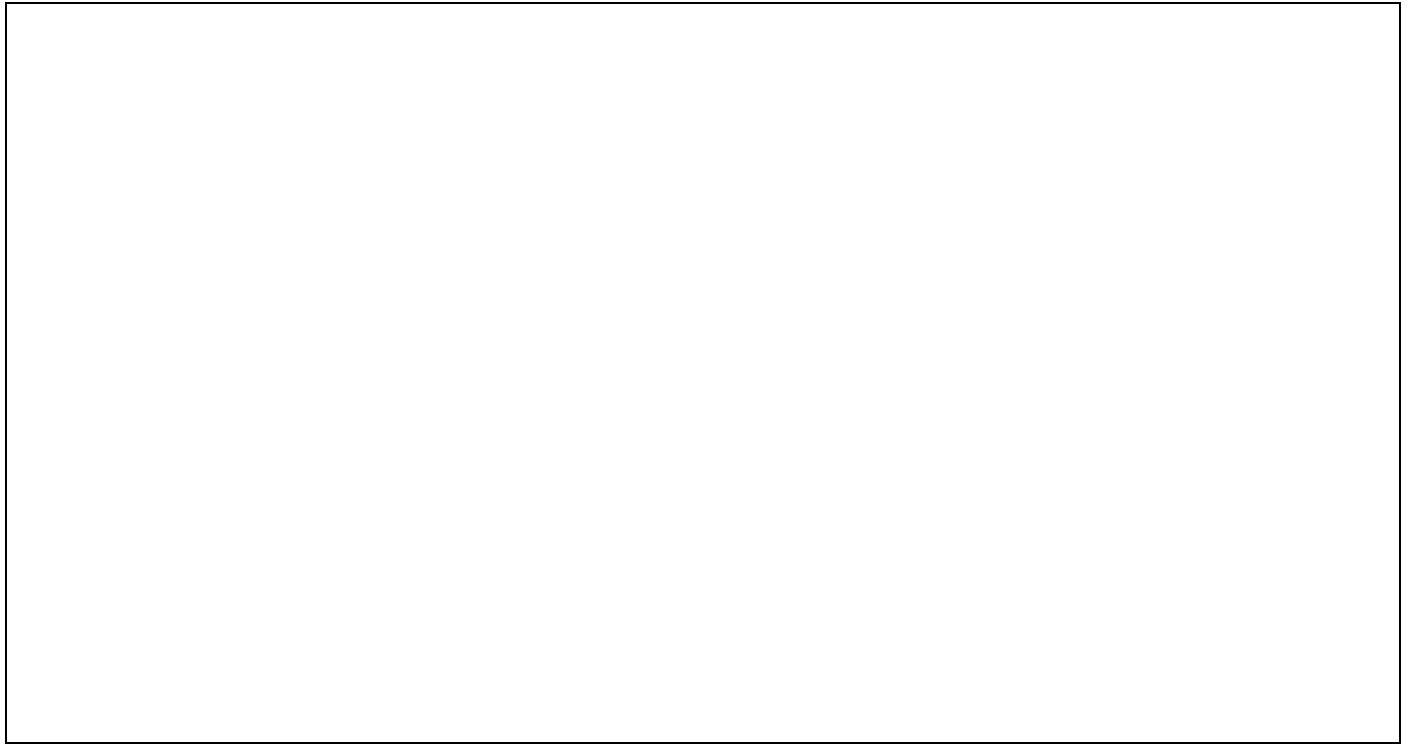
