## **AMYAC NATIVE TITLE COMPENSATION SETTLEMENT AUTHORISATION MEETING**

This letter is to provide notice for a consultation and consent (authorisation) meeting for Antakirinja Matu-Yankunytjatjara (**AMY**) native title holders.

### **Why is there a meeting?**

AMYAC has been negotiating with the State of South Australia to settle the AMY native title holders' claim for native title compensation for acts done by the State within the AMY native title determination area. AMYAC is now ready to present a proposed settlement of the claim to the native title holders to make a decision.

This meeting will be about the native title holders making decisions to resolve the claim against the State for compensation. Decisions about what the native title holders want to do with the compensation will be made at a later date, once the claim against the State is settled.

All AMYAC members and AMY native title holders are encouraged to attend. More information can be found in the authorisation meeting notice at **page 4**.

### **Consultation session**

Ahead of the authorisation meeting there will also be a roadshow of consultation meetings to share information and discuss the native title compensation matter. Decisions about the native title compensation **will not** be made at these consultation meetings. All decisions will be made by the native title holders at the authorisation meeting on 18 November 2025.

The consultation sessions will include community sessions to share and discuss information about the settlement, and drop-in sessions for community members to speak with the AMYAC lawyers about their questions and concerns.

## AMYAC AGM

Please note that this notice is for a native title meeting to make decisions about the AMYAC native title compensation claim. The AMYAC AGM is intended to be postponed until early next year, to give members and native title holders time to consider and make decisions about the native title compensation claim as a matter of priority.

AMYAC members will receive a separate notice for the AMYAC AGM when it is ready to be called early next year.

## Native title holders' assistance

Members that attend the meeting can seek reimbursement for accommodation upon checkout by providing a receipt to the Trust office. This will be reimbursed within 3-4 business days. The name and bank details on the receipt will need to match the details of the member who applied for assistance.

## **NOTICE of CONSULTATION AND CONSENT (AUTHORISATION)** **MEETING**

AN ANTAKIRINJA MATU-YANKUNYTJATJARA NATIVE TITLE HOLDERS MEETING is to be held at 9.30 am on Tuesday 18 November 2025 at the AMYAC office, Lot 715 Hutchison Street, Coober Pedy SA 5723.

ALL AMYAC MEMBERS, AND ANY OTHER NATIVE TITLE HOLDERS NOT AS YET REGISTERED AS AMYAC MEMBERS, ARE INVITED & ENCOURAGED TO ATTEND.

### **MEETING PURPOSE:**

1. Consultation with the Native Title Holders about, and obtaining the consent of the Native Title Holders for, Antakirinja Matu-Yankunytjatjara Aboriginal Corporation RNTBC (**AMYAC**) to:
  - a. execute (sign), and support the registration of, the Antakirinja Matu-Yankunytjatjara Native Title Compensation Settlement Indigenous Land Use Agreement with the State of South Australia;
  - b. consent to orders for a determination of compensation in the Antakirinja Matu-Yankunytjatjara native title compensation claim (SAD61/2022); and
  - c. make a revised native title determination application, and consent to the revision of the AMY native title determination (*Lennon on behalf of the Antakirinja Matu-Yankunytjatjara Native Title Claim Group v The State of South Australia* [2011] FCA 474), to reflect the settlement of the compensation claim and remove extinguishment by pastoral improvements, and other incidental changes.
2. Update the Native Title Holders about negotiations with the Commonwealth government regarding native title compensation for the Adelaide to Darwin Railway and the Woomera prohibited area, including consultation with the Native Title Holders about, and obtaining the consent of the Native Title Holders for, AMYAC to make a compensation application about those matters.

**This meeting is for those persons who are native title holders for the Antakirinja Matu-Yankunytjatjara Native Title Determination Area. This includes members of the Antakirinja Matu-Yankunytjatjara Aboriginal Corporation RNTBC and other native title holders with native title rights and interests in this land.**

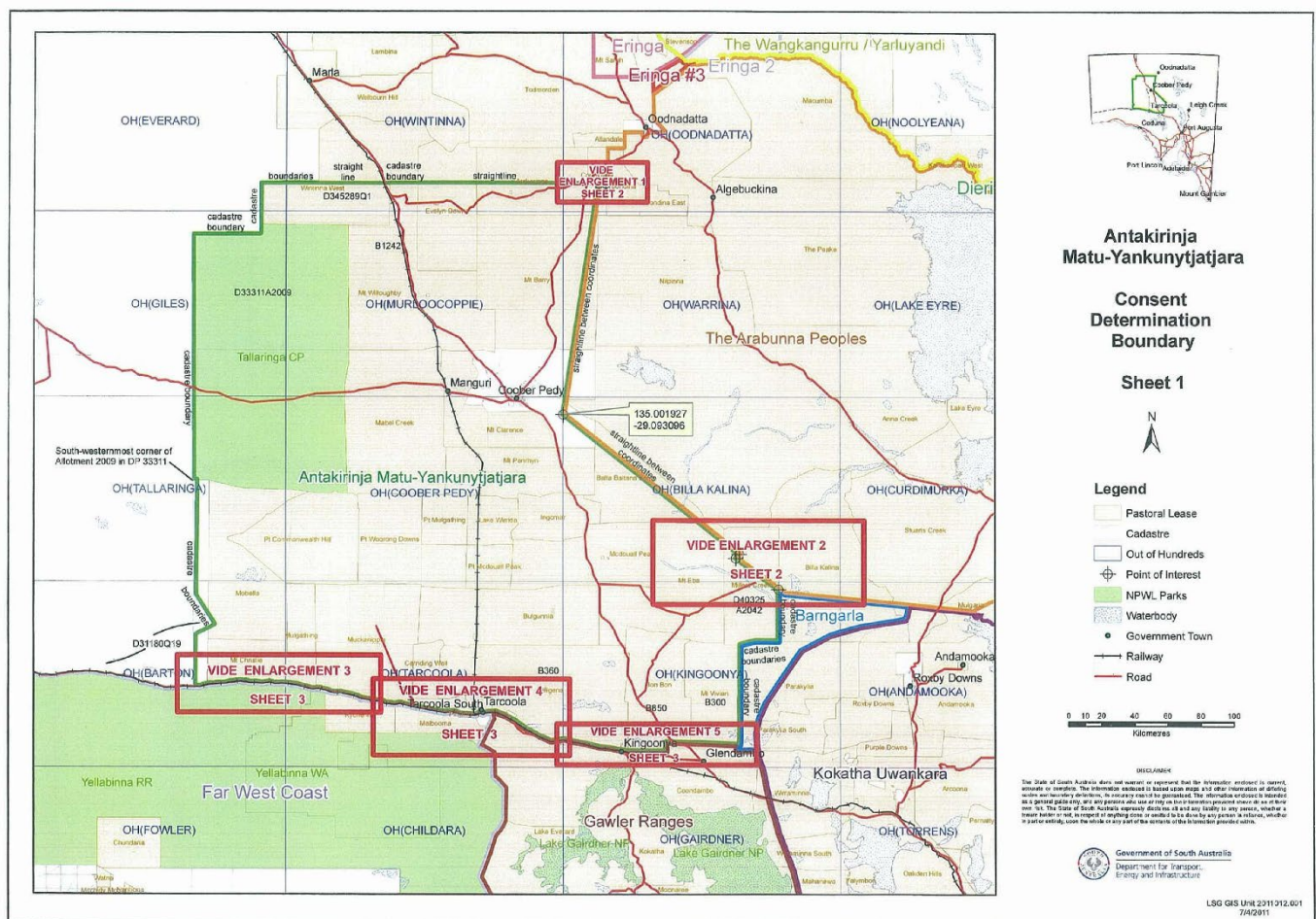
## Who are the native title holders?

Those Aboriginal people who, under the relevant traditional laws and customs of the Western Desert Bloc, have a spiritual connection to the native title determination area (**Determination Area**) and the *Tjukurpa* associated with it because:

- (a) the Determination Area is his or her country of birth (also reckoned by the area where his or her mother lived during the pregnancy); or
- (b) he or she has had a long term association with the Determination Area such that he or she has traditional geographical and religious knowledge of that country; or
- (c) he or she has an affiliation to the Determination Area through a parent or grandparent with a connection to the area as specified in (a) or (b) above;

and are recognised under the relevant Western Desert traditional laws and customs by other members of the native title holding group as having rights and interests in the Determination Area.

The Determination Area is shown in the map below:



Limited accommodation and fuel will be provided to those members needing to travel to Coober Pedy for the meeting.

**Accommodation** - AM-YAC members are to book and pay for their own accommodation.
